## HOW TO GET MILITARY COMBAT EYE PROTECTION (MCEP)

## MUST KNOW STUFF FOR COMMANDERS AND SUPPLY CHANNELS

Points of contact for ordering:

- (1) Standard Ordering Procedures (funded requisitions) can be used for the standard type classified eyewear and authorized commercial eyewear.
- (2) THE SUPPLY SYSTEM CAN PROVIDE ALL OF THE SPECTACLES AND GOGGLES ON THE APEL LIST. SHOULD THE STANDARD SUPPLY SYSTEM NOT MEET THE NEEDS OF MISSION COMMANDERS, THE PRIME VENDOR PROGRAM CAN BE UTILIZED TO OBTAIN THE PRODUCT IN A TIMELY MANNER.
- (3) Contact the following POC's to order authorized commercial eyewear alternatives using the DEFENSE LOGISTICS AGENCY (DLA) prime vendor program:
- (A) Procurement center/unit can also SEND MILITARY INTERDEPARTMENTAL PURCHASE REQUEST (MIPR) funds to the DSCP Prime Vendor Program to obtain items by part number and NSN. We encourage units making large quantity purchases to REQUEST CURRENT prices FROM THE PRIME VENDOR PROGRAM MANAGER AS THE LISTED FEDLOG PRICES MAY NOT BE CURRENT. - (B) All NSN's can be ordered via the e-mall. Customers can go into the e-mall link <a href="https://emall6.prod.dodonline.net">https://emall6.prod.dodonline.net</a> or call the Central Call Center at 1-877-352-2255, option 3, then 3 again. The customer can speak to a person by using option 3, then 1 (instead of the second 3). Both options are available to take orders 24 hours a day. Registration is required for the web, but it is easy and available on-line (customer service/account/create new account) on the lower left hand side of the home page.
